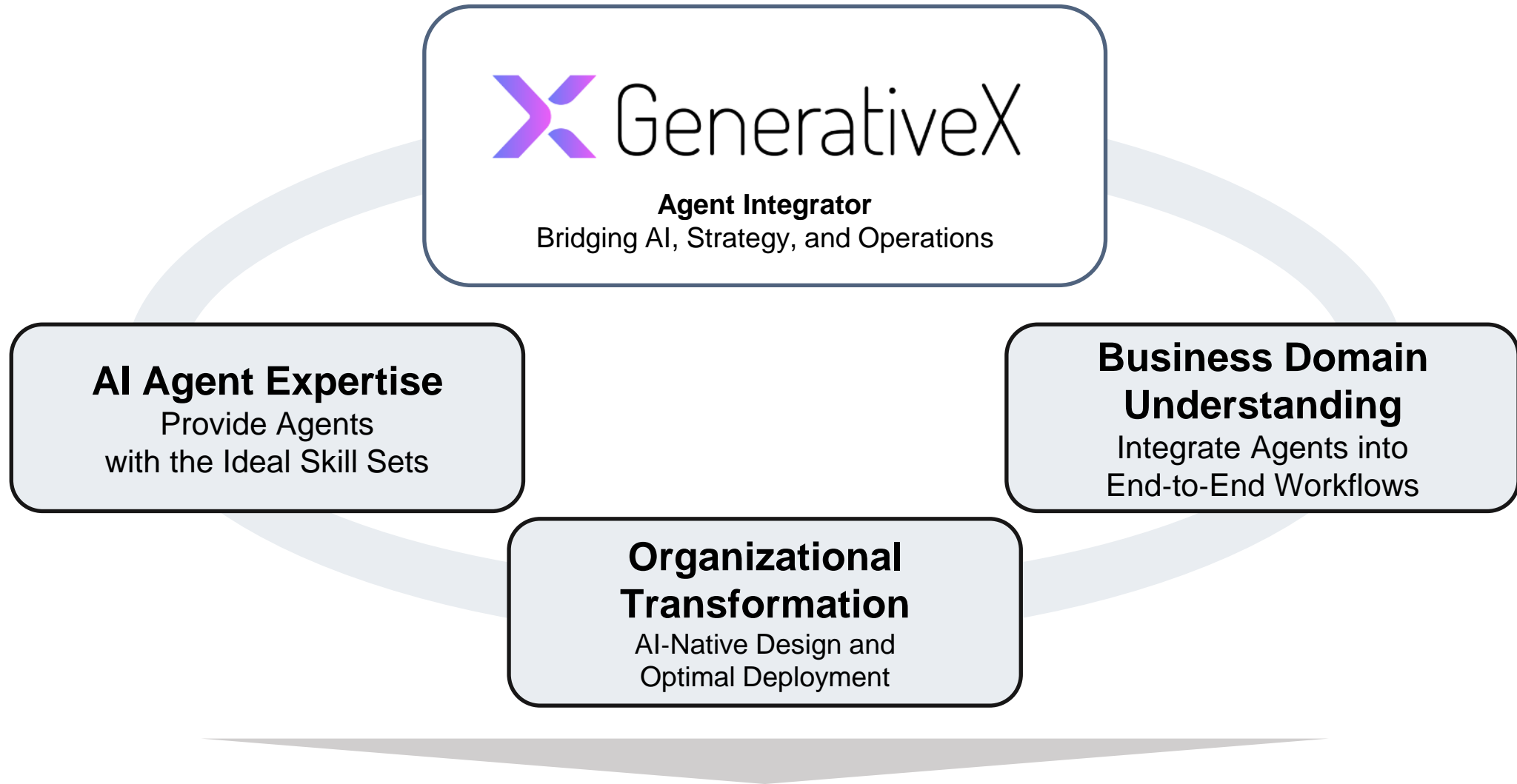

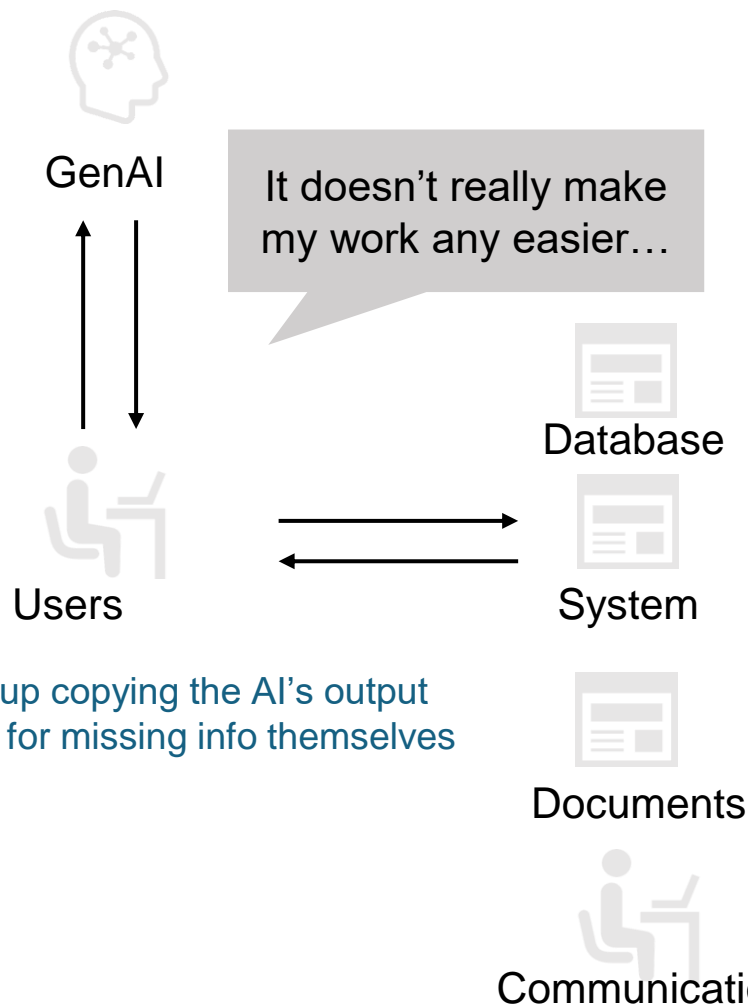

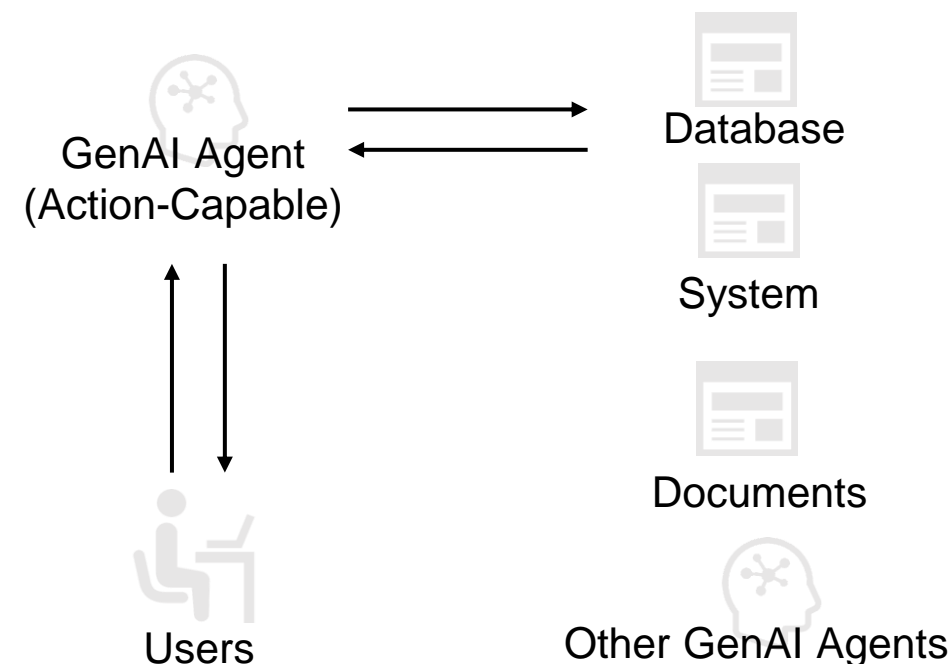

Users end up copying the AI's output or searching for missing info themselves

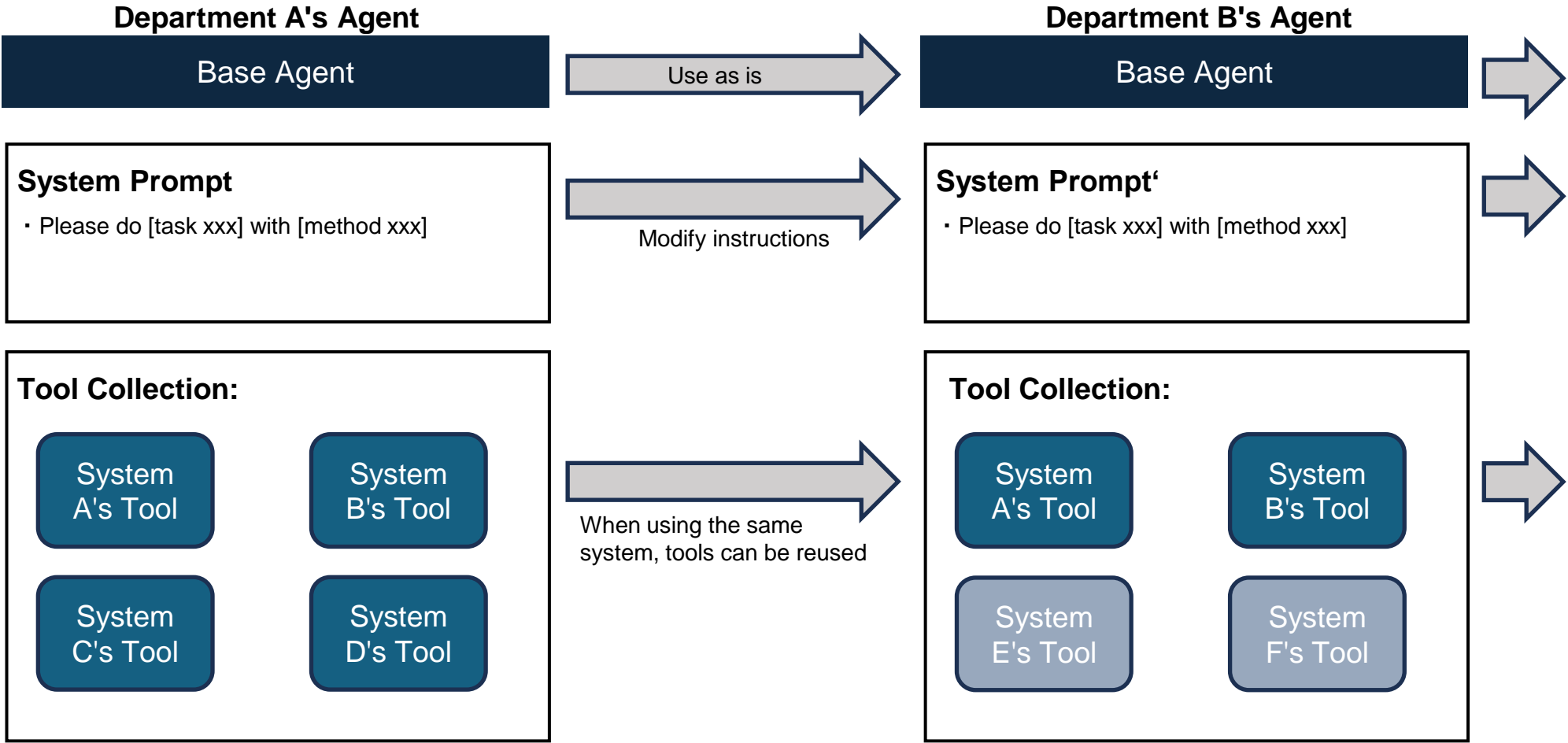
