## Generative AI Opportunities and Risks:

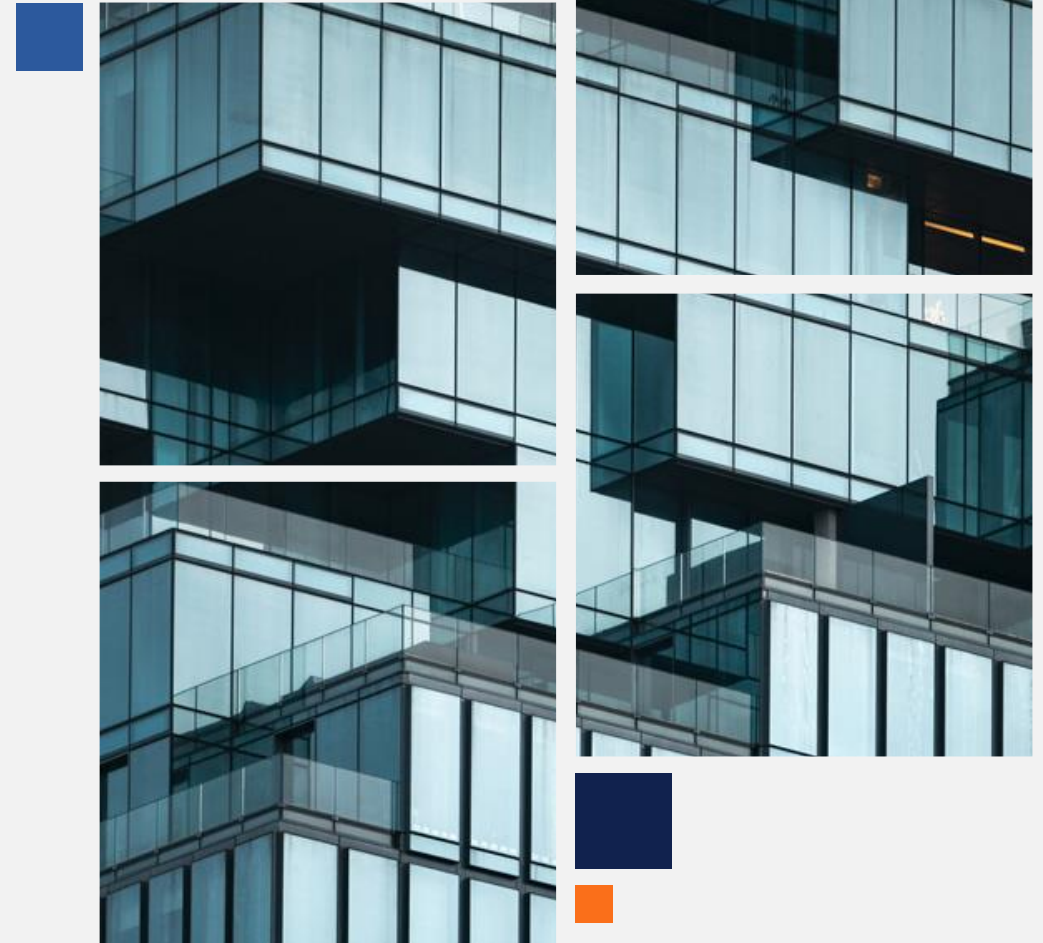
Unprecedented opportunities arise with Generative AI, but new risks also accompany its implementation.

Regardless of the chosen AI pathway, establishing a robust foundation is crucial for successful implementation and sustainable development.



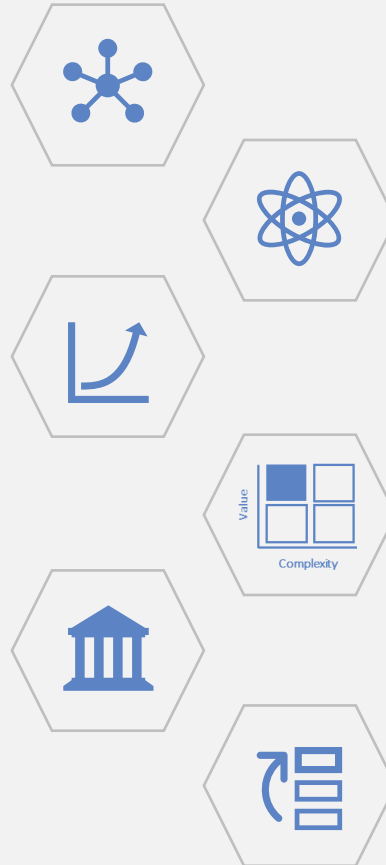

## AI Maturity Dimensions

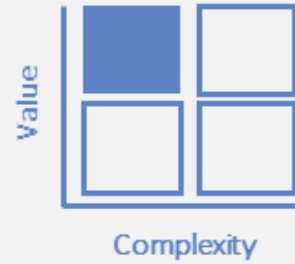
